A. CommonBond – Howard Lake Goldendale

This one is removed, Certificate is not needed.

B. Connelly Development – Granite Ridge Apartments

Diana Dyste

Mike W – City of Delano has been very supportive of this venture. 55 unit building, 4 HPH units, 4 Dis units. Focus on families 3-2br, 1-3br, no 1br. Tracking data from past 3-5yrs. Crimes against persons in recent history is hardest to overcome. Baker Tilly Service provider, hx of working well with them. High success rate, good stability, low turnover. Vouchers? Quite a few come with this to eventually transition to permanent housing. Bckgrnd checks: Standard goes back 10y, we go back 3-5y. HPH units, flexible with homeless in accepting with criminal backgrounds. Wright Co. 4 households in that county, low numbers due to development of housing personnel, large growing homeless group here so very much needed. Available late summer of 2024.

C. Duffy Development – Monticello Workforce Housing

Kevin D – See PP presentation. Third attempt for this project getting funded. Local in twin cities, own 13 tx credit properties since 1992, continue to own these properties. Partnering with Salv. Army for Supportive entity. Construction complete end of summer 2024. Rent \$1050 1br. \$734 for Supportive

Housing. Work through prior evictions, and credit reports. ?'s: Criminal convictions look back 7ys. This is not for supportive housing, still 5yrs. Training for staff HPH, etc. Conference put on for this population's issues. Kevin will get back to Tim with specifics.

D. Reuter Walton Development – North Branch Apartments

Sydney Ohlendorf/ Kathleen Castle

Kathleen C Landyn Grp, New Pathways is Service Provider. See PP presentation. In Chisago County. 65 units, 100% supportive, 1, 2, & 3br's. 30% to 60% AMI. PWD are Section 8, 11 units. CoC sees most singles, but will also provide focus on families. Bkgcks, past 5y. ?'s Looks at appeals in criminal issues on a case by case assessment. Training for staff at Michael's working with New Pathways to assume training based on NP recommendations to maintain successful rental issues. Completions in late summer 2024.

E. Mille Lacs Corporate Ventures – Mission Creek Estates

Trent Rogers/ Sara Treiber

Sara T – 40 units in Hinckley, Pine County. 100% affordable housing, right next to Lady Luck Apartments in Hinckley. Also, Red Willow Estates in Onamia. Supportive housing through Lakes & Pines. Criminal bkgrnd 5y back violent/drug crimes. Will work thru case by case situations to not deny. Credit score is used, work through all scores, not dc'd due to this. We do look at past evictions, 2y back, not stringent. HPH are 4 – 2br. ?'s Going back to Mgmt training for HPH population. People hired for supportive positions are focusing on MH as well as other concerns. L&P would be able to recommend useful training, trauma informed issues. 63 households in Pine Co. Needs are there.

Louise Z – Landyn Grp. Julia Donaldson VOA Property Mgr. 41 unit building 100% Section 8, 4 units for HPH. Sr. (55 and older) and Disabled population. Shared supportive services through existing program in the area. Existing program will be renovated this year. Criminal bkgrnd 1-5y. Drug related 1yr. and criminal related case by case of convictions. Working with MN Housing thru issues from Anoka program. Training for staff to deal with HRH populations.
