1. Coordinated Entry Common Assessment Tool

Brenda has been doing training with this common assessment tool, she can provide the tool, along with the process so everyone is doing it similarly. This is aimed at everyone using this tool consistently so data is collected and completed the same way. Training Wednesday at 1p to 4p. Thursday training is at 10a to 1p. These are "In person" at this time for questions/answers.

2. PIT Data Presentation

They are now summarizing PIT/HIC data from Jan. 25th 2023. See the PP presentation. This PP will be shared with everyone. This is on a statewide level with CoC's split to see numbers. Central CoC number were discussed in depth from 2009 to 2023, minus 2021 numbers, unsheltered was not collected that year. Trends in Housing Types, ES, TH & Unsheltered 2018 to 2023. Numbers appear to have gone down significantly from 22-23 due to some groups not reporting their numbers. See breakdown for listing of counties. Hotel vouchers are hard to include in the data to make sense. Why do we have many so many shelter beds not being utilized? Can shelter beds and hotel vouchers be separated to know the specifics? Some Emergency shelter beds may not identify as full or as DV. Some don't want to be separated from their partner, child or pet depending on if it's a men's/women's or family shelter. And, doubled up numbers are not reported. Increase in CH. Ana will send out the PP she just presented.

3. Governing Board Strategic Planning

Got together to work on SP July 20th, see action plans sent out to review. Would appreciate feedback on these topics. 4 Action Plans: Generate Interest/CoC Purpose/Networking, Who we are serving/Community, CoC Structure, and Systemic Issues. TH is short term housing 90d to 2yrs from stepping out of jail, treatment, etc. then moving onto independent living. Allowing flexibility to be more inclusive in giving people a chance, limiting criminal to go back 2-3yrs instead of 10. Stearns Co. set aside \$30,000 to cover the fee for Beyond Backgrounds of \$300. Send questions and/or thought to Ji to further this discussion. All good!
