

# Program Manager Job Description

Job Title: Program Manager

**Position Description:** Provide grant writing, program management, oversight, and full grant administration of Small Cities Development Program (SCDP) grant awards and management and performance of lead-based paint inspection services. Additional responsibilities include research of additional programs and funding resources related to housing rehabilitation.

## **Major Areas of Responsibility**

- Overall management and administration of SCDP grants from community outreach and grant application writing to construction project management and project closeouts
- Development, monitoring, updating, and following of SCDP Policies and Procedures
- Assure compliance with all applicable State and Federal funding requirements
- Overall management of lead-based paint inspection services and conducting lead-based paint assessments and clearance inspections
- Other duties as assigned

## **Specific Responsibilities**

- 1. Community Outreach and Grant Writing
  - a. Research
  - b. Outreach to potential city/county applicants
  - c. SCDP preliminary and full application preparation and submission
  - d. Facilitate meetings and public hearings with interested communities and grant awardees

  - a. Grant kick off due diligence
  - b. HUD Environmental Review
  - c. Policies and Procedures for all parties city, participants, contractors, CMHP
  - d. Marketing, Kick-Off Meetings, Application processing
  - e. Inspections and scope of work creation
  - f. Bidding/contracts/financing
  - g. Construction Management: draws, inspections, conflict resolution
  - h. Project Closeouts

#### 3. Lead-Based Paint Inspection Services

- a. Complete initial required licensing training and maintain license through annual training and continuing education requirements for lead-based paint inspectors
- b. Conduct initial lead-based paint assessments on pre-1978 SCDP properties and prepare and provide reports to applicable parties
- c. Conduct final lead clearance inspections and prepare and provide reports to all applicable parties
- d. Maintain lead-based paint inspection equipment
- e. Research other lead-based paint inspection service opportunities outside of SCDP

- Excellent ability to multitask and quickly change tasks as needed
- Excellent oral and written communication skills
- Comfort with public speaking
- Excellent organizational skills and attention to detail

- Access to reliable transportation with ability to travel within a 4-hour radius of St. Cloud
